# Advocacy and Health Policy

- Federal:
  - House Appropriations Committee FY2020 Labor/HHS/Education Funding Bill - \$1.68 billion in health center funding
  - Inaugural meeting of the NACHC 340B Strategic Advisory Council
- State:
  - PBM bill S.359 passed House and Senate
    - Prohibits payments to independent RX less than PBM affiliate RX
    - Limits co-pays to lesser of copay or alternative cash price
  - Proviso 33.20 with \$5 million allocated to health centers
  - Physician's Assistant Bill passed
